The ACRO Face Shield is made from 0.020" Thick polyethylene terephthalate glycol, commonly known as PETG or PET-G. It is a thermoplastic polyester and is 100% Recyclable and Reusable. The ACRO Face Shield can be disinfected, sanitized, and reused making it a cost-effective solution.

The ACRO Face Shield is a clear plastic shield that protects frontline workers from exposure to COVID-19 droplets by providing coverage from ear-to-ear and hairline to neck.
